Overview: During the current pandemic, residents of long-term care (LTC) facilities—including nursing homes—have been especially hard hit with high COVID-19 infection and death rates. Increased underlying comorbidities with complex medication regimens and advanced age are risk factors for enhanced susceptibility to SARS-CoV-2 virus.

Senior care and consultant pharmacists from around the country were called upon to develop deprescribing protocols and strategies for medication management and review during these extraordinary times, with most services provided remotely in LTCFs. This session will describe these guidelines from the ASCP COVID-19 task force.

Overview: Control of hypertension and mortality related to hypertension has been on the rise over the past five years. This is disappointing because antihypertensive therapy is a proven treatment modality to reduce risk of cardiovascular events in patients with hypertension, including older patients.

This session will review the 2017 ACC/AHA hypertension guideline recommendations for management of hypertension, and analyze the evidence supporting lower BP goals for the treatment of older patients. Strategies to mitigate potential challenges for managing hypertension in older patients, particularly those who present with resistant hypertension, will be included.

Overview: The popularity of medical marijuana continues to grow in the United States. As of September 2020, 33 states and Washington, DC have laws legalizing medical marijuana. Eleven states and Washington, DC have legalized recreational marijuana. In addition, a growing number of states have laws specifically addressing the use of cannabidiol (CBD) for medical, as well as nonmedical, purposes. This session will discuss the evidence regarding the proposed medical claims for CBD and medical marijuana. Current and proposed legislation on the Federal and state level, including DEA and FDA initiatives, will be presented. Finally, the speakers will discuss the nuances of generating guidelines for managing CBD and medical marijuana usage in the non-acute setting for Premier member facilities.

Michael J. Alkire

Michael J. Alkire is the President of Premier. He has more than 20 years of experience in running business operations and business development organizations at Deloitte & Touche and Cap Gemini Ernst & Young. Before joining Premier, he served in a number of leadership roles at Cap Gemini, including North American responsibilities for supply chain and high-tech manufacturing.

Dr. Fish has published more than 150 original research articles, review articles, and book chapters dealing with the areas of critical care, antimicrobial use, and infectious diseases. His research interests include antimicrobial pharmacokinetics and pharmacodynamics, the use of antimicrobials in critically ill and immunocompromised patients, drug dosing in severe organ dysfunction, and antimicrobial resistance. Dr. Fish is active in many state and national professional societies and has served in many leadership roles within these organizations. He also has a passion for global health and has served as a visiting professor or a member of volunteer medical teams in nearly a dozen countries

Prior to teaching at the Harvard School of Public Health, he was a television reporter in Boston, twice winning the DuPont Columbia Award, often referred to as the Pulitzer Prize of broadcast journalism.


